





Mergers

In a merger, the boards of directors for two companies approve the combination and seek shareholders' approval.



Management Buyouts

A company's executives purchase a controlling stake in another company, taking it private. Such transactions are typically M&A financed disproportionately with debt, and the majority of shareholders must approve it.



Consolidations

Consolidation creates a new company combining core businesses and abandoning the old corporate structures.

Acquisitions

In a simple acquisition, the acquiring company obtains the majority stake in the acquired firm, which does not change its name or alter its organizational structure.

Tender Offers

In a tender offer, one company offers to purchase the outstanding stock of the other firm at a specific price rather than the market price. The acquiring company communicates the offer directly to the other company's shareholders.





Asset Acquisitions

In an acquisition of assets, one company directly acquires the assets of another company.

EQUITY TRANSACTIONS

Equity financing refers to the sale of company shares in order to raise capital. When a company is still private, equity financing can be raised from angel investors, crowdfunding platforms, venture capital firms, or corporate investors. Ultimately, shares can be sold to the public in the form of an IPO.

DEBT TRANSACTIONS

Debt financing occurs when a company raises money by selling debt instruments, most commonly in the form of bank loans or bonds. Such a type of financing is often referred to as financial leverage. As a result of taking on additional debt, the company makes the promise to repay the loan and incurs the cost of interest. It can then use the borrowed money to pay for large capital expenditures or to fund its working capital.

HYBRID TRANSACTIONS

Hybrid securities are investment instruments that combine the features of pure equities and pure bonds. Hybrid securities can be divided into two components: The fixed income component (the bond part) and the variable income component (the equity part). Examples include preferred stock, convertible bonds, and in-toggle notes.



FAMILY BANK

We supported Family Bank (Kenya) in successfully raising over USD 34 million in debt for onward lending to tea farmers in 2021. This funding is aimed at promoting sustainable farming practices including biodiversity, conservation, and climate change mitigation.

TRANSAFRICA WATER

In 2021, we assisted Kenyan water solutions company TransAfrica Water in obtaining a USD 2 million convertible loan.
